CHEMIGATION FOR CONTROLLING FOLIAR PLANT PATHOGENS

Use SaniDate 12.0 to suppress and control plant pathogens and their associated diseases such as Aerial blight, Ascochyta blight, Brown spot, Cercospora leaf spot, Early blight, Common rust, Frogeye leaf spot, Fusarium head scab, Gray leaf spot, Gray mold, Northern corn leaf blight, Powdery mildew, Southern rust, Striped rust, Tan spot, Tar spot, Yellow rust, and White mold.

Use SaniDate 12.0 to suppress and control bacterial diseases such as Common blight, Bacterial leaf streak, Bacterial wilt, Blackleg, Brown spot, and Halo blight.

Use SaniDate 12.0 at a rate of 1:1,000-1:20,000 through the irrigation system at the time of seeding or transplanting, as well as a periodic treatment throughout the plant's life. Multiple applications can be made, as there is no mutational resistance with this product.
