CHEMIGATION FOR CONTROLLING FOLIAR PLANT PATHOGENS

Use SaniDate 12.0 to suppress and control foliar plant pathogens and their associated diseases.

Use SaniDate 12.0 for fungal and bacterial disease control at a rate of 1:1,000-20,000 through the irrigation system at the time of seeding or transplanting, as well as a periodic treatment as needed throughout the growing season through harvest. Multiple applications can be made, as there is no mutational resistance with this product.
