FIRST AID

If in eyes • Hold eye open and rinse slowly and gently with water for 15–20 minutes. • Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. • Call a poison control center or doctor for treatment advice.

If on skin or clothing • Take off contaminated clothing. • Rinse skin immediately with plenty of water for 15–20 minutes. • Call a poison control center or doctor for treatment advice.

If inhaled • Move person to fresh air. • If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. • Call a poison control center or doctor for treatment advice.

If swallowed • Call a poison control center or doctor immediately for treatment advice. • Have person sip a glass of water if able to swallow. • Do not induce vomiting unless told to do so by the poison control center or doctor. • Do not give anything by mouth to an unconscious person.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS: DANGER: Corrosive.

Causes irreversible eye damage. Do not get in eyes, on skin or on clothing. Wear goggles, or safety glasses. Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove and wash contaminated clothing before reuse.

ENVIRONMENTAL HAZARDS: To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the treatment area. Rinsing application equipment over the treated area will help avoid run off to water bodies or drainage systems.

PHYSICAL AND CHEMICAL HAZARDS: Corrosive. Strong oxidizing agent. Do not use in concentrated form. Mix only with water in accordance with label instructions. Never bring concentrate in contact with other pesticides, cleaners or oxidative agents.

GreenCleanFX Liquid Algaecide is not to be combined or mixed with any other pesticide concentrates.

WATER TREATMENT

CONTAINERIZED WATERS (*with no outflow to the natural environment*)

To suppress, control and prevent algae and cyanobacteria in containerized waters such as Water Gardens, Fish Ponds, Ornamental Pools/Ponds, Ornamental Waterfalls, Fountains.

Waters treated with GreenCleanFX Liquid Algaecide are permissible to be used without interruption.

DETERMINING WATER VOLUME

Measure length (L), width (W), and average depth (D) in feet (ft.) or meters (m) and calculate volume using one of the following formulas:

Square/Rectangular:

$$L(\text{ft.}) \times W(\text{ft.}) \times D(\text{ft.}) \times 7.5 = \text{Gallons}$$

$$L(\text{m}) \times W(\text{m}) \times D(\text{m}) \times 1000 = \text{Liters}$$

Circular/Elliptical:

$$L(\text{ft.}) \times W(\text{ft.}) \times D(\text{ft.}) \times 5.9 = \text{Gallons}$$

$$L(\text{m}) \times W(\text{m}) \times D(\text{m}) \times 786 = \text{Liters}$$

$$\frac{\text{Avg. Length (ft.)} \times \text{Avg. Width (ft.)}}{43,560} = \text{acres}$$

APPLICATION INSTRUCTIONS

1. Apply early in the morning under sunny, calm conditions.
2. Measure the pH of water before adding GreenCleanFX Liquid Algaecide. If pH is below 7.0, adjust the water pH to between 7.0-8.0.
3. Add 1-2 teaspoons per 50 gallons of pond/fountain water. Distribute recommended dose as evenly as possible to several areas around the pond/fountain so product evenly disperses throughout the pond/fountain. GreenCleanFX Liquid Algaecide may also be mixed in a bucket of pond/fountain water and evenly distributed around the pond or fountain.
4. Do not shut off pump(s) or aeration device(s); aeration must be continuous during treatment for 48 hours.
5. Repeat dose every 3 days until algae is under control. Once algae is controlled, apply dose once a week.

Removing excessive algae growth from pond/fountain will reduce the amount of decaying organic matter in the pond.

STORAGE AND DISPOSAL

PESTICIDE STORAGE Store in original container in a cool, dry well-vented area, away from direct sunlight. Do not allow product to become overheated in storage. Do not store in a manner where cross-contamination with other pesticides or fertilizers could occur.

PESTICIDE DISPOSAL AND CONTAINER HANDLING Nonrefillable container. Do not reuse or refill this container. If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
