# **SECTION 4: First-aid measures**

# 4.1 Description of necessary first-aid measures

General advice	Consult a physician. Show this safety data sheet to the doctor in attendance.
If inhaled	Remove person to fresh air and keep comfortable for breathing. Call a poison center or doctor if you feel unwell. Acute and delayed symptoms and effects: May cause respiratory irritation. If swallowed Rinse mouth. Do NOT induce vomiting. Immediately call a poison center or doctor. If vomiting occurs naturally, have victim lean forward to reduce the risk of aspiration.
